- a. State Coordinator's Report
 - Arkansas (Shelby): Census, census and more census! BAS 2020 boundary submission review with jurisdictions. Filing changes this week. State 911 board about to release NG911 implementation. Continued work on PLSS and corner recovery



- ii. Iowa (Patrick): Census and lidar, a couple counties flown last winter. Will collect the eastern side of the state this spring. Wrapping up counts and BAS state-wide updates.
- iii. Illinois (Mark Y): Working with esri RE a hub site plan the PSAPs will be using. Finalizing lidar collection and processing; IL natural hazards catalog created with state 911 and FEMA

- v. Missouri (Tony): new state CIO; state clearinghouse group has new work-study program which will enable more work and coordination to be done. 2021 Missouri GIS conference Columbia.
