- i. Arkansas (Brian): Redistricting is all the rage. AR Forum hosted a meeting on the esri redistricting tool and its recorded and available online.
- ii. Iowa (Patrick): buried in broadband grants; clearinghouse related updates; MLA with BAS has been signed with census.
